

PRESIDENT'S REPORT

Having now completed this my third consecutive year as President of our great club I am particularly pleased to report that 1993 has been a continuance of successful and responsible management. I congratulate the management team on your behalf for their dedication to the task and personally thank all for their support in this regard.

The Treasurer's Report again reflects this good management and shows a further improvement from that outlined in the 1992 Report, in respect to the reserves towards possible future synthetic developments. Budgeting to maintain an equitable status in a non profit sporting club is never easy. However TEM has always endeavored to ensure the minimum impost on the membership, whilst meeting its commitments, and in recent years managing to establish these reserves for current and future facilities.

The latter is largely attributable to the "right decision" taken in our joint venture at the HMHC. Financially, this venture has allowed us to contain costs to be met by the membership, and to build on these reserves.

I will be the first to concede that our joint venture at HMHC has had its problems, as I have generally been involved in them first hand. The most apparent problems are that of the cramped conditions and the lack of ideal/dedicated club amenities. I am pleased that most of you have attempted to make the most of these sometimes difficult conditions.

I can inform you that a number of people have been very proactive in investigating all possible options to improve on these conditions. In this my last year as President(!) nothing would give me more pleasure than to officially announce the development of a new synthetic facility.

However, many will be aware of the Task Force, comprising representatives from TEM & Hawthorn Hockey Clubs and Malvern & Hawthorn Councils, which has spent a great deal of time and effort in pursuing this proposal. A detailed report is currently with the two Councils with a decision on the Task Force recommendations expected by the end of the year.

False hopes notwithstanding, I am very confident in a most favourable outcome for TEM and greatly encouraged by the tremendous support demonstrated by the City of Malvern. The outcome may yet see TEM relocate to the City of Malvern - an exciting prospect I am sure you will agree.

I will not elaborate on the Club's on field performances in 1993, preferring to leave that to the following Section Reports. Suffice to say that TEM Hockey Club remains a force in all sections and we have clearly consolidated our position in the top levels in both Men's and Women's hockey. I commend our two senior Coaches in 1993, Bill Hooper and John Toner, for their obvious and significant contribution in achieving this great result.

Congratulations to all our Perpetual Trophy and Best & Fairest winners in 1993 and special congratulations to our Best Club Person, **Bill Hooper**, winner of the Bruce Hulston Trophy.

As always there is a great deal of support behind any Presidency and this year has been no exception, I thank all those who have contributed in this regard. I especially want to thank my very able committee for their time and efforts in the management of the Club, and in making 1993 another successful year.

again I mean in its broadest context. I highlighted this issue in my 1992 Report and little has changed. We all need to consciously pursue this aspect in the interests of the future of the Club.

FINANCIAL REPORT

FOR THE YEAR ENDED 31ST OCTOBER 1993

SUMMARY

The club made a profit for the year of \$2746 (1992 \$5976).

The profit was only achieved after including a final receipt of \$3000 from the sale of the lights at Lords Reserve, \$20000 by way of distribution from the Hawthorn Malvern Hockey Centre and \$2900 from fundraising (the fund raising committee should be applauded!).

At the 31st October, the club had cash at bank of \$2547 and a balance of \$21180 was held in the No.2 Bank Account.

The Club's 50% equity in the Hawthorn Malvern Hockey Centre at 31st October was \$15051 comprising Cash at Bank \$14658 and Debtors \$393.

DIVISIONAL RESULTS

This year the men's division had a net loss of \$4584 which was consistent with the 1992 loss of \$4952.

The Woman's division had a loss of \$3028 compared to a profit in 1992 of \$778.

The Junior's division had a loss of \$1399 compared with a loss in 1992 of \$285.

The losses in the three divisions were offset by a surplus in the General division of \$11757 (1992 \$10435).

SYNTHETIC GROUND LOAN

During the year there were two repayments of the ground loan, each for an amount of \$5590.

The total payments of \$11,180 reduced the principal owed by \$5684 with the balance of \$5496 being interest paid.

The Committee decided to only make minimum loan repayments until a decision has been made on whether the Club will move to another ground, hence the increase in our cash balances.

MEMBERSHIP

This year I have included a schedule which analyses our membership base.

This analysis shows that the number of senior men members paying full fees has declined significantly between 1992 & 1993, whilst all other areas had about the same (but not increased) memberships over the two years.

FINANCIAL ORGANISATION

There was no change in the basic structure of the financial team from that of the the last few years, that is, Wendy Penpraze was the Club Treasurer which involved paying bills, writing receipts, banking money and voting at Committee meetings. Barry Penpraze recorded all the transactions on his computer and produced monthly accounts for the Committee. I co-ordinated the production of the annual budget, prepared the final accounts and helped the Committee interpret the monthly accounts.

I would once again like to record my appreciation of Wendy and Barry's efforts and on behalf of the finance team thank the Committee for their assistance and guidance during the year.

1994

Next year in all likelihood some costs will increase and if we are to balance our finances it will be imperative that all expenditure be carefully examined to ensure that the maximum benefit is being obtained for our money. An example of such an expense requiring scrutiny by the incoming committee is ground hire for training sessions.

In addition to minimizing costs we must be seeking to maximize our revenue and in this area the incoming Committee needs to examine areas such as sponsorship and fund raising events.

T.E.M HOCKEY CLUB INC. NOTES TO AND FORMING PART OF THE ACCOUNTS FOR THE YEAR ENDED 31ST OCTOBER 1993

NOTE 1

The accounts have been prepared on a historical cost accrual basis.

NOTE 2

During the 1986/7 year \$2000 was transferred from Members Equity to the Synthetic Ground Reserve to be specifically set aside for the club's synthetic hockey surface.

NOTE 3

The assets are valued in the following manner:-Assets acquired prior to 1/11/83 have been valued on the historical cost basis less an allowance for dimunition in value to 31/10/84.

Fixed assets acquired after 31/10/84 have been valued at historical cost.

Depreciation has been provided to write off the cost of fixed assets over their estimated useful life using the straight line method.

NOTE 4

A Trust has been established by the Hough Family, the income of which is to be used at the discretion of the club's committee.

NOTE 5

At the 31st October 1993 TEM Hockey Club Inc. had a total equity in the Hawthorn Malvern Hockey Centre of \$15,051 comprising the club's 50% share of Cash at Bank (\$14,658) and Debtors (\$393).
